Additionally, McCalpine provided the purposes behind these priorities.

McCalpine shared the SAP Outcome areas for 2024-2028 with the CWACT Full Commission Members in attendance.

McCalpine presented the work done with internal engagement for this plan, which includes some items such as Engaging staff to help them see themselves in the plan and shape the strategic vision.

The targeted external engagement has two key phases:

- 1. Review proposed priorities and outcomes areas (With the ACTS)
- 2. Review of the draft SAP

McCalpine shared the schedule for this project with a timeline of May – January 2024 which ends with adoption of the plan by the Oregon Transportation Commission (OTC).

Councilor Jackie Montague asked how ODOT defines belonging in ODOT, McCalpine answered that belonging is how many staff want to work and be apart of ODOT and their plans and practices.

Councilor Montague asked about the timeline and ODOT being behind schedule with implementing this plan. McCalpine noted there needs to be changes made to the schedule that came from executive leadership, but they are not currently behind schedule with those updates considered.

	Commissioner Pat Malone noted he would like more information on the project of connecting and repairing the West Coast Electric Highway.	
	Jake Easter noted he will take this question down and will bring it back to the ACT to distribute with their members. Councilor Jan Napack asked about infrastructure funds from the	
	federal government. McCalpine noted that yes, these funds are being leveraged for this plan and were used in many of the 2021-2022 projects.

	Crawford shared the funding challenges for the 27-30 STIP, and why this STIP will not be as healthy in budget terms as previous STIPs. Additionally, a snapshot was provided as a comparison of the 24-27 STIP and the 27-30 STIP, which had a 14% decrease in it. There will be \$70 million out of a \$3 billion dollar budget unallocated for this three-year cycle.	
	The unallocated funds will be divided up and allocated by the OTC in November 2023. The goal will be focusing on safety projects.	
	Councilor Napack asked what percent of ODOT's budget the STIP	

	covers. Crawford answered that it covers the full budget.	
	Commissioner Malone asked if the dollar amounts for 24-27 STIP are set between the categories. Crawford answered that most of the dollars are set as programmed percentages as firm allocations.	
	Councilor Gil Sylvia asked if these were inflation adjusted items. Crawford answered said they are adjusted but she isn't sure what percentage they are adjusted by.	
	Councilor Montague noted that she liked the idea of focusing on safety and saving the funding to help ensure potential projects could be fully completed.




Equity Guidance for ODOT Advisory Committees




Overview

Effective January 1, 2022, House Bill 2985, directs ODOT to diversify its advisory committees to reflect Oregon's population's racial, ethnic, and ability composition, as determined by the most recent American Community Survey.



Objective

The bill explicitly calls out ODOT's statutory advisory committees; however, in alignment with ODOT's Strategic Action Plan and our value of embracing equity and fostering a culture of inclusion, the agency will include all advisory committees in this mandate.

- Prioritize diversity, equity, and inclusion by identifying and addressing systemic barriers to ensure all Oregonians benefit from transportation services.



RE: CWACT Priority Projects Update

This memorandum contains an overview of the ongoing process for Cascades West Area Commission on Transportation (CWACT) members to generate a list of priority projects throughout Lincoln, Benton, and Linn counties.

Background

The CWACT began discussing regional projects of significance in 2020 in anticipation of a new federal infrastructure bill. The conversation happened primarily at the Technical Advisory Committee (TAC) level and resulted in a list of projects sorted by topic (safety, bike/ped, planning, etc.). As the details of the bill were still unknown, staff thought sorting into categories would be the most beneficial to future conversations. When the topic arose again in 2022, it was determined regional projects would be better sorted by corridor and not mode. This reinforces the CWACTs comments to the OTC over the past few years, as well as assists regional ODOT staff.

The Oregon Department of Transportation (ODOT) region staff are often asked for local priorities with very short lead times. While there is no funding identified at this time, by developing a list of projects, staff can work together with regional ODOT staff to advocate for funding and inclusion in other projects. A priority project list prepares the region to advocate for projects in the region. This could include federal legislative member designated projects (i.e. earmarks), future federal funding packages, or future state funding packages.


Collectively, this illustrates the importance of CWACT members, and CWACT as a region, identifying projects of both local and regional significance.

Process and Schedule Update

While there are funding streams available to both states and cities/counties, in April 2023 CWACT staff proposed developing two project lists: one for the ODOT system and one for the local system, as the most beneficial. The process is the same for both lists. The list of projects for the ODOT system is sorted by corridor, as CWACT has been advocating for that approach with the Oregon Transportation Commission (OTC). The local projects can be either on state highways or local routes.

CWACT Staff shared an interactive mapping Tool (Figure 1) to identify regional projects with the CWACT TAC in September 2023 and the Full Commission in November 2023. The map allowed participants to drop a State/Federal Highway Corridor Projects pin or a Local Projects pin, and then provide comments. The responses from the map were combined with previous projects identified in 2020.

Figure 1: Interactive Mapping Tool



The draft list of regional priority projects is attached. The projects are organized by corridor and include key information about the project including Transportation System Plan identification, segment location, a project description, and an estimated cost if available. The list is not meant to be exhaustive, and it will be updated periodically.

In April 2023 Staff proposed as schedule that was delayed. The updated schedule for collecting and prioritizing projects is below:

- Held a CWACT TAC meeting on April 18, 2023 to explain the process; which is between the
 Executive Committee meeting and Full Commission meeting. This meeting reviewed the
 process and encouraged members to begin thinking of needs (Complete).
- Informed the Full Commission of the process at the April 27, 2023 meeting, and reminded members to nominate TAC members if they have not done so already (Complete).
- Solicited projects via an online survey (Complete).
- Reconvene the TAC to review projects in detail and discuss ranking criteria (Pending).
- Bring the updated list(s) to the Full Commission in April or June, for review and discussion. Include overview of discretionary grant programs that may be applicable.
- By summer of 2024, have an approved list of CWACT projects and regional priorities.

Discussion and Next Steps

Staff requests feedback from the Full Committee on the overall process. It is worth mentioning projects that are ranked as a lower priority by the CWACT may receive funding over higher ranked projects due to opportunities presented by other projects. In addition, there is still some ambiguity over how projects will be sorted or prioritized. Staff intend to bring this topic to the TAC.

RE: Federal Lands Access Program

Information from Jamie Lemon with the Federal Highway Administration.

- In late 2022/early 2023, the project team for the Oregon FLAP Needs Assessment (https://highways.dot.gov/federal-lands/programs-planning/studies/or-flap-needs-assessment) did outreach across the state with local, state, and federal partners to identify unmet access needs to Federal lands in Oregon.
- About 170 needs were identified and have since been synthesized/summarized. I'd like
 to present the results for the Cascades West region and share information on next steps
 for the study, which will involve scoring all of the unmet access needs against the current
 FLAP scoring criteria and categorizing the overall list into "high", "medium" and "low"
 funding suitability for the Federal Lands Access Program.

Staff ask if the CWACT Board is interested in a presentation at the April meeting.

STATE OF OREGON CONDITIONS OF VOLUNTEER SERVICE

Volunteer Insurance Coverage (VIC)

As a volunteer working in a State of Oregon agency, you need to understand the extent to which you are covered by State of Oregon insurance for liability and personal injury/illness. Please read the following carefully and sign below.

The conditions and limits of this protection are as stated in the Oregon Tort Claims Act, ORS 30.260-300, and Oregon Department of Administrative Services Risk Management Division Policy Manual, 125-7-202.

Motor Vehicle Liability

If you use a personally owned vehicle in the course of your duties, you are required to have automobile liability insurance to provide your primary coverage for any accidents involving that vehicle. State provided auto liability coverage will apply on a limited basis only after your primary coverage limits have been used.

Volunteer Injury Coverage (VIC)

The agency has elected to have VIC for authorized volunteers. It is limited to only injuries due to an accident while performing volunteer duties. The state will pay medical treatment bills, disability, death and dismemberment benefits to the limits and under the terms and conditions described in Oregon Department of Administrative Services Risk Management Division Policy Manual, Volunteer Injury Coverages, 125-7-204. If you are injured in a private vehicle, the owner's insurance is responsible for your medical bills.
